- WDB Elected Official Appointees

 - Congressman Anthony Brown, Senator Jim Rosapepe & Council Member Deni Taveras will be notified by Walter Simmons and Jamie Gunnell of their appointment by the Office of the County Executive.
- WDB Chamber of Commerce Appointees
 - David Harrington from the Chamber of Commerce accepted his appointment but wanted to review the Board Member Job Description. Walter Simmons will send Mr. Harrington the Board Member Job Description not that is has been approved.

 - Prince George's county government has pushed back the opening phases of the county and the public are still unable to enter government buildings. The AJC will remain closed to the public through the end of the year.

• WIOA 4th Quarter PY19 Annual Report

Walter Simmons

 Walter Simmons reviewed the WIOA 4th Quarter PY19 Annual Report and noted that these reports will be reviewed by the committees who will provide recommendations to the board every quarter.

Covid-19 Board Member Updates

Board Members

- Tamara Robinson, Regional Director of 1199 SEIU Training and Unemployment Funds, voiced her concern that many organizations continue to focus on traditional barriers to access as opposed to focusing on the new/current barriers to access. Tamara provided an update that her staff members are implementing direct phone calls to assist residents, completing intense case management, and providing direct application assistance.
- Gloria Brown Burnett, Director of Prince George's County Department of Social Services, announced that DSS is using a 1-800 state number to accommodate the large influx of calls. Gloria also voiced concern that the lack of access to digital services may hinder residents from completing job interviews as most interviews are now being held virtually.
- Kari Pompilii provided an overview of the Maryland Department of Labor's efforts to respond to COVID-19 and the impacts of the pandemic.
- Stephen Neal, President/CEO of K. Neal Truck & Bus Center, voiced concern about workforce availability.
- Rasheeda Jamison, President & CEO of United Communities Against Poverty, Inc. suggested looking at non-traditional job opportunities. Rasheeda provided an update that they have begun non-traditional training including courses in auto detailing, catering & photography.
- Jasmine Taylor shared that Six Flags of America completed all virtual/phone interviews to hire 1,800 employees. The largest challenge is the training & onboarding process. In addition, public transportation proved to be an issue for weekend shifts.
- Charnetia Young, Sr. Director of Workforce Programs at the Learning Center CVS/Caremark, shared that public transportation has been a major challenge. The reduced bus schedule is not conducive with essential operating hours at their retail locations, especially for entry-level / reentry employees. Additionally, Charnetia shared that employees hired for office positions are given a company laptop, as well as a MiFi if they do not have access to Wi-Fi at home.
- Ebony Stocks provided an update that the Economic Development Corporation is developing a survey to collect data from businesses in their network.
- Jacqueline McSears Boles provided an update that Industrial Bank is hiring various positions featuring a virtual application process.
- Yvette Snowden announced that Prince George's County Community College is starting primarily remotely for the Fall Semester. Limited classes were offered over the summer & will continue into the fall for courses that require

hands-on training components. Limited computer lab access is available for registered students.

- Jean Paul Cadet shared that Prince George's County Public Schools are preparing materials for students to take home with instructions for lessons and activities at home. A challenge has been providing devices to each student, as well as providing a platform that can access necessary software from MacBooks and PCs. They are looking into partnerships with various organizations for programs that are not so easily put in a box, such as culinary programs.
- Troy Green, Recruitment & Employment Manager at the University of Maryland Capital Region Health shared that there is a breakdown in the populations they work with, particularly with entry level individuals in the interviewing, on-boarding and training processes.
- Juan Carlos Linares, General Manager, provided an update on Tanger Outlets National Harbor and their efforts in response to COVID-19. Juan Carlos shared that a challenge Brand Partners are facing include hitting payroll needed while hitting the bottom-line. Reduced hours have also cutback the opportunity for workers. Without being able to bring in additional shoppers, they will not be able to increase the workforce.
- Mitch Mitchell, Regional Vice President representing Pearson Education, shared that all employees have been brought back from layoffs as of July 13, 2020. Pearson Education is working to ensure all curriculum materials are on a digital platform but are facing challenges working with the schools due to their technology base. Pearson's next initiative is to provide PPE to schools in their network.
- Sara McDonough, Director of Adult Education at the Prince George's County Community College, shared that the lowest level is the hardest to serve online. Zoom is being used across the board, and they are experiencing an increase of interest in GED programming.
- Walter Simmons provided an update on virtual initiatives provided by Employ Prince George's.
