- Summer Youth Connections Awarded to ADC Management Solutions. ADC Management Solutions also provided services for the Summer Youth program last year and was successful. Contract has been executed.
- Apprenticeship Expansion Study & Strategy Awarded to for Urban Institute. The RFP is intended for evaluation and study in our efforts to expand apprenticeship in Prince George's County. Execution will take place in the coming weeks.
- Careers Pathway Mapping Project –Awarded to CAEL. This RFP is our opportunity for us to ensure that we are creating business-driven programs and supporting our business partners and community partners in real time.
